Absorption into the body leads to the formation of methemoglobin which in sufficient concentration causes cyanosis. Onset may be delayed 2 to 4 hours or longer., To the best

of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

The following applies to aromatic nitro compounds in general: systemic effect: methaemoglobinaemia with headache, cardiac dysrhythmias, drop in blood pressure, dyspnoea, and spasms; principal sign: cyanosis (blue discolouration of the blood).
