Dehydration, weight loss, dermatological effects, and thyroid disturbances have been reported. Central nervous system effects that include slurred speech, blurred vision, sensory loss, ataxia, and convulsions may occur. Diarrhea, vomiting, and neuromuscular effects such as tremor, clonus, and hyperactive reflexes may occur as a result of repeated exposure to lithium ion., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

The following applies to lithium compounds in general: when handled or used inappropriately, the absorption of large quantities is followed by CNS disorders, agitation, spasms, ataxia (impaired locomotor coordination) due to disturbed electrolyte balance.
