After apparent recovery a person may experience metabolic acidosis, convulsions, and coma hours or days later. Further complications may develop leading to acute liver necrosis that can result in death due to hepatic coma., Symptoms may be delayed., Effects due to ingestion may include:, Epigastric pain., Diarrhea, Vomiting, Nausea, hematemesis
