SECTION 4: First aid measures

4.1 Description of first-aid measures

General advice

If inhaled

After inhalation: fresh air.

In case of skin contact: Take off immediately all contaminated clothing. Rinse skin with water/ shower.

If swallowed: give water to drink (two glasses at most). Seek medical advice immediately.
